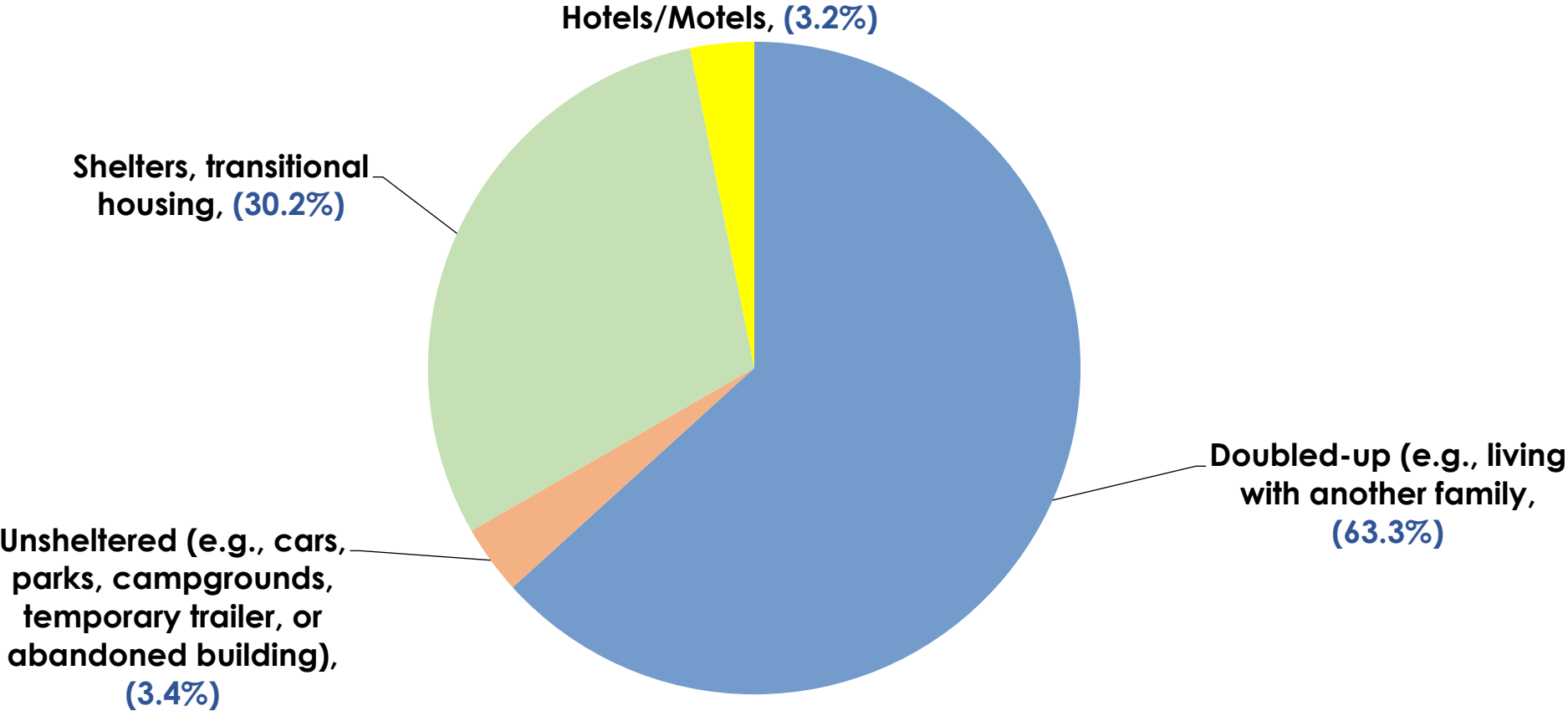

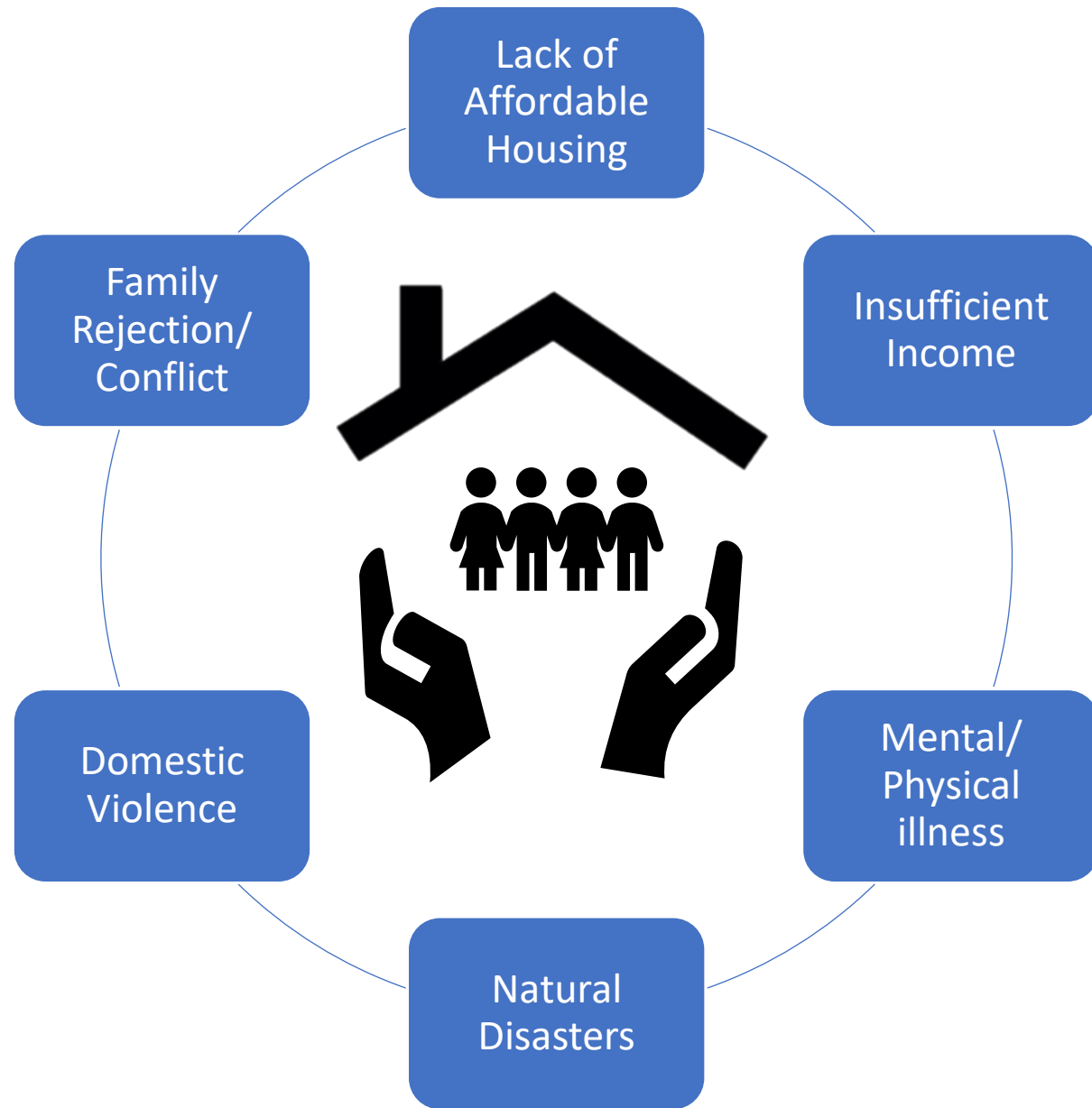

Educational Barriers



Lack of **basic** resources like a safe and stable place to live, food, and clothing.



Difficulty accessing school, immunization records, other documentation necessary for school enrollment, and school supplies.



Challenges finding transportation to enroll with the school registration office or to attend school daily.

Identification

Under the McKinney-Vento Act, the local liaison is charged with ensuring that homeless children and youth are identified by school personnel through outreach and coordination activities with other entities and agencies.

Who Fills Out the Housing Questionnaire?

A Housing Questionnaire should be filled out:

1. **FOR** all students enrolling in school and for all students who have a change of address in grades preschool-12.
2. **BY** the student's parent, person in parental relation, or in the case of an unaccompanied youth, by the student directly.

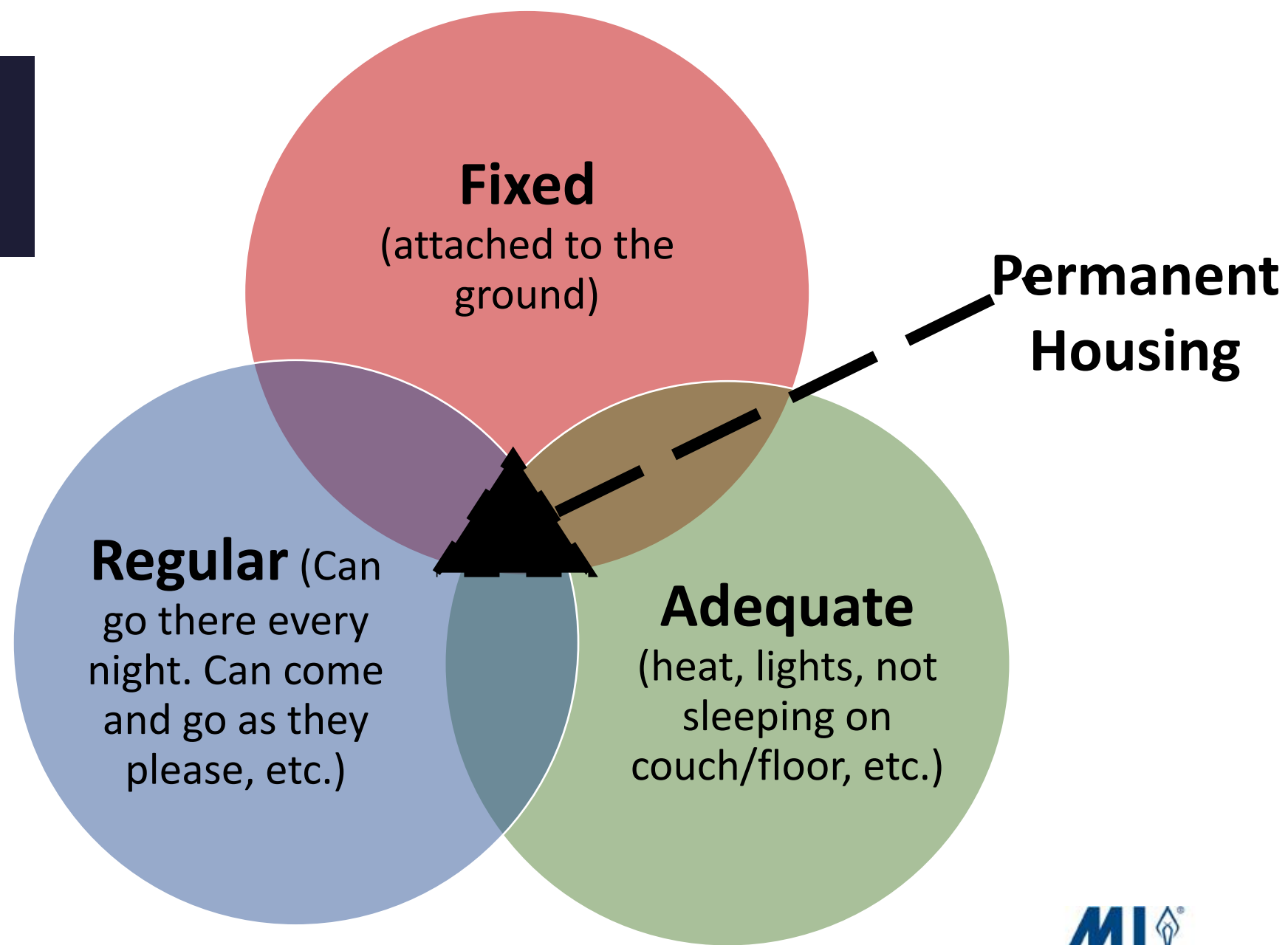

Definition of Homeless

The term “homeless child or youth” means individuals who lack a fixed, regular, and adequate primary nighttime residence.

Homelessness: Living Conditions

- Sharing the housing of others due to loss of housing, economic hardship or a similar reason
- Living in emergency or transitional shelters
- Living in motels, hotels, trailer parks, camping grounds due to the lack of alternative adequate accommodations
- Abandoned in hospitals
- Living in a public or private place not designed for sleeping
- Living in cars, parks, abandoned buildings, substandard housing, bus or train stations, etc.
- Migratory children living in circumstances described above
- Unaccompanied youth living in circumstances described above

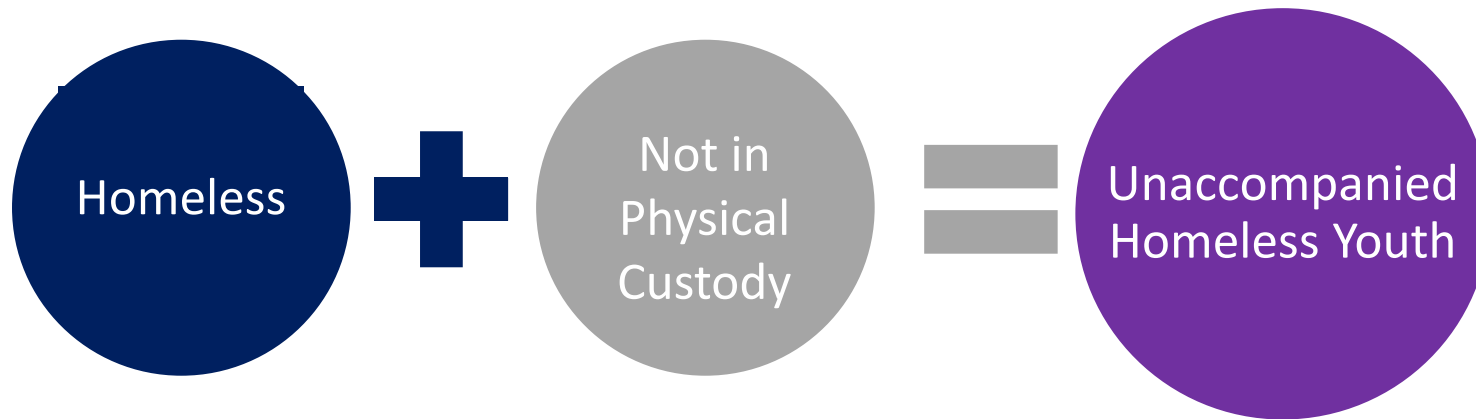

Definition of an Unaccompanied Homeless Youth

An unaccompanied youth is a child or youth that is not in the physical custody of/not living with a parent or guardian.

To be eligible for services under the McKinney-Vento Act, the youth must also meet the definition of homeless.

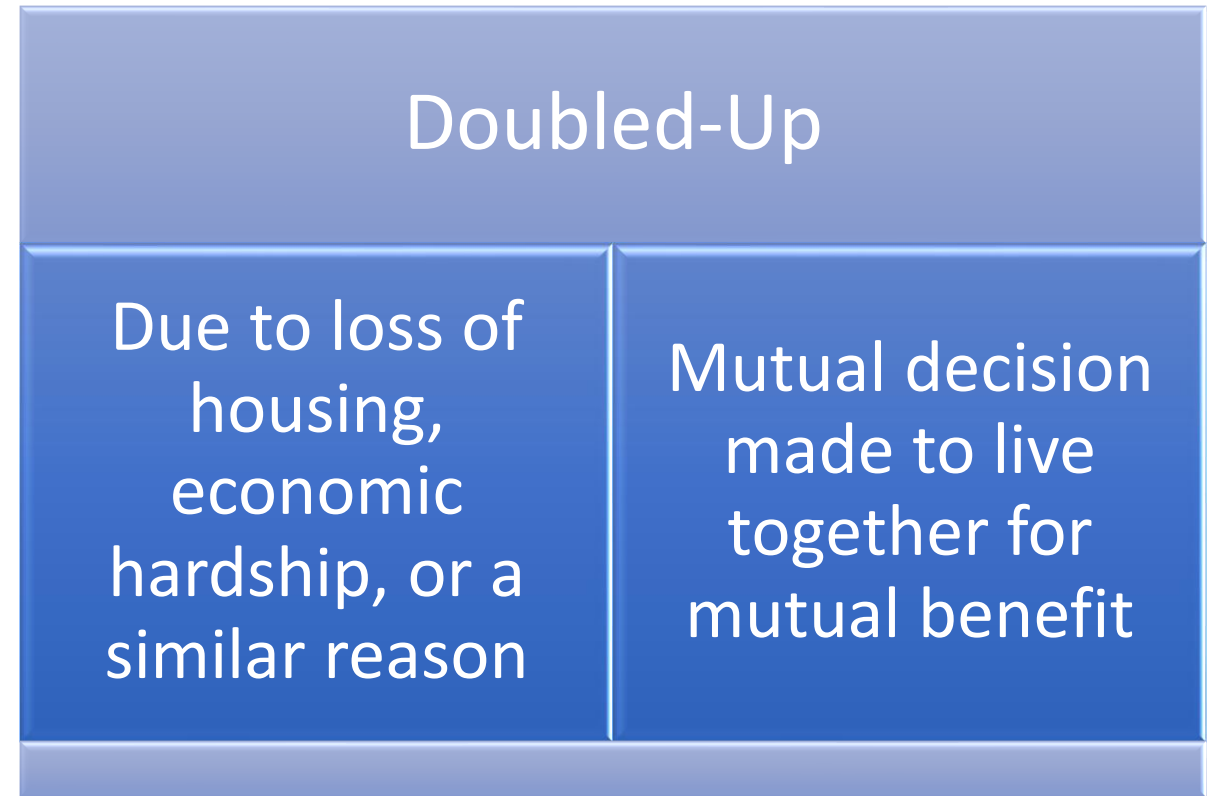

Understanding “Doubled-Up”

Sharing housing with others...

- due to loss of housing, OR
- economic hardship, OR
- a similar reason

Sharing the Housing of Others...

Implies that the child or youth is staying in someone else's residence.

Clarifying questions:

- Does the family or youth have any legal right to be in the home?
- Can the family or youth be asked to leave at any time with no legal recourse?

Due to the Loss of Housing...

Implies that the student has no personal housing available.

Clarifying questions: Did the family or youth lose previous housing due to

- An eviction or foreclosure?
- Destruction of, or damage, to the previous home?
- Unhealthy or unsafe conditions?
- Domestic violence?
- Abuse or neglect?
- The absence of a parent or guardian due to abandonment, parental incarceration, or a similar reason?

Due to Economic Hardship...

Implies that limited financial resources have forced the family or youth to leave the personal residence and share housing due to an inability to pay the rent/mortgage and other bills.

Clarifying question:

- Did economic hardship due to an accident or illness, loss of employment, loss of public benefits, or a similar reason force the family or youth to share the housing of others temporarily?

Addressing Identification Problems



Think About It
How would you address each challenge?

- Parents/youth hide their homelessness due to feelings of embarrassment or fear.
- Parents/youth do not know that their living situation may entitle their child/them to certain protections.
- Parents/youth do not want everyone to know about their circumstances and are worried that information might be used to negatively stereotype their child/them.

Addressing Identification Problems



Parents/youth hide their homelessness due to feelings of embarrassment or fear.

- Do not use the word “homeless.” Instead, try “students in temporary housing” or similar language.

Parents/youth do not know that their living situation may entitle their child/them to certain protections.

- Be transparent about questions and explain the protections and services available to children who are homeless (e.g., eligibility, priority enrollment).
- Use language to describe homelessness that reflects the living arrangement, (e.g., “doubled-up” or “staying at a shelter”).

Addressing Identification Problems



Parents/youth don't want everybody to know about their circumstances and are worried that information might be used to negatively stereotype their child/them.

- Discuss living situation in an office where other parents, staff, and students can't overhear.
- Share how the information will be used (e.g., it will only be shared with staff on a need-to-know basis; program is required to report data on temporary housing).
- Provide internal trainings to staff for increased awareness and sensitivity.

Identification Strategies

- **Raise awareness** throughout district schools and the community about the definition of homelessness, the rights provided to eligible students under the McKinney-Vento Act, and the role of the local liaison in working with others to identify homeless students.
- **Conduct community assessments** that include data on homelessness in the area; levels of poverty among families; trends in foreclosures, evictions, and the availability of affordable housing; and student mobility.
- Work with appropriate district and school authorities to **ensure that local policies and procedures comply with the McKinney-Vento Act.**



Identification Strategies

- Provide **targeted outreach** through information sharing and -gathering activities.
 - Housing Questionnaire in district enrollment packet
 - Posting notices of the rights of McKinney-Vento students in the community where family and youth frequent
- **Share information** about McKinney-Vento eligibility and services in student handbooks, on the school district website, in brochures, and other informational materials distributed throughout the district schools and communities.

Determining Eligibility



The local liaison serves as the district's lead homeless education contact and is required to fulfill the duties of the position as established in the Act [42 U.S.C. § 11432(g)(6)(A)]. According to the Act [42 U.S.C. § 11432(g)(6)(A)], local liaisons must ensure that children and youth experiencing homelessness are identified by school personnel through outreach and coordination activities with other entities and agencies.

Eligibility Determination



Homelessness = lacking a fixed, regular and adequate nighttime residence.



If any one of these criteria is missing, the student is eligible for McKinney-Vento benefits.



A student may be considered homeless for an unspecified length of time if housing is not fixed, regular and adequate.

Preparing for the Conversation

- Review the McKinney-Vento definition of homelessness.
- Adopt a strengths-based approach toward families.
- Practice active listening techniques, using non-judgmental language when reiterating the information shared and during advising.
- Prepare questions in advance to meeting with families.

Get the Facts: Learn about the Family's Situation

- Talk with the family in a private location.
- Explain your role as the McKinney-Vento Liaison.
- Clarify the purpose of the conversation.
- Ask permission to ask questions.
- Avoid using the word homeless.

Questions to Ask to Determine “Fixed/Regular”

- Is your current housing situation fixed to one place? (i.e., not in a vehicle, camper etc.)
- Is this a permanent arrangement? How long do you plan to stay at this address?
- What were the circumstances that caused you to leave your previous housing?

Questions to Ask to Determine “Fixed/Regular”

- Do you have a key to the place you are living?
- Do you stay in the same place every night?
- Could your friends/relatives ask you to leave at any time?
- Are you sharing the home equally or are you more like guests in the home?
- Where would you go if you could not stay where you are currently living?

Questions to Ask to Determine “Adequate”

- How many people are living in the home? How many are sharing a room?
- Are the child(ren)/youth sleeping in a bedroom or in a different space in the house?
- Is there heat, running water and electricity?
- Is there adequate space to meet the physical and psychological needs of the child(ren)/youth staying there?

Student Privacy Rights Under FERPA

- Strategies used by school districts to identify McKinney-Vento students should be grounded in sensitivity and demonstrate a commitment to protecting student confidentiality.
- According to the McKinney-Vento Act, information about the living situation of a child or youth experiencing homelessness is not deemed to be directory information; rather it is considered a student education record and must be provided with the applicable confidentiality protections.

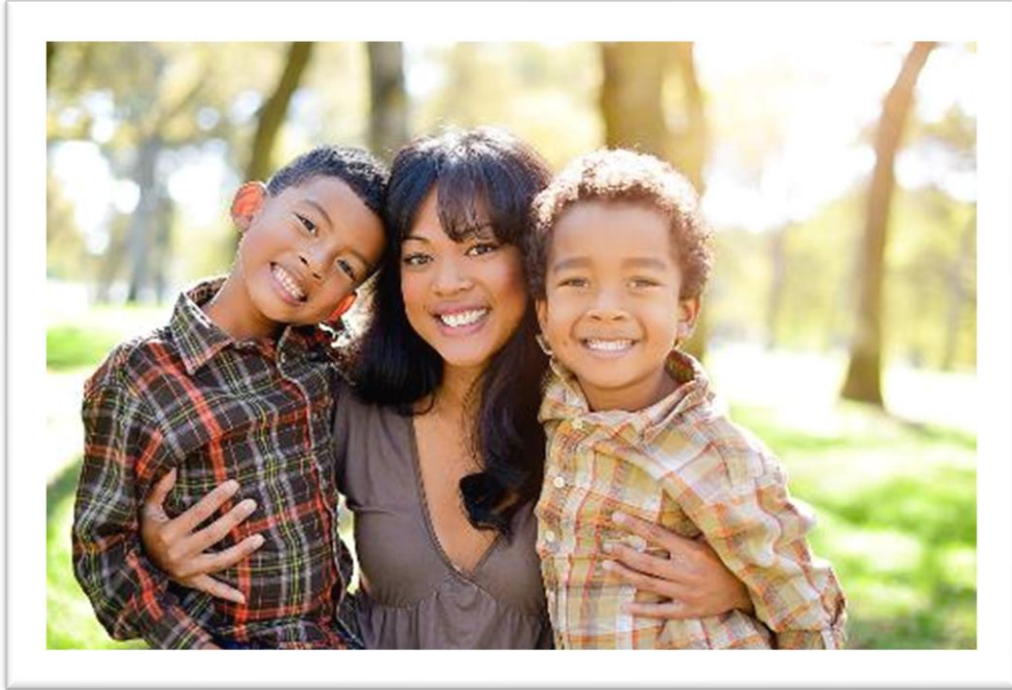

Questions to Ask to Determine Eligibility

- Where would you go if you couldn't stay with your mother?
- Are there any occupancy issues where your mother is staying?
- Are you and your children sleeping in a bedroom or in another place in the house?

Determining Eligibility: Step-by-Step Guide

Prepare

- Prepare for a conversation with the family.

Get

- Get the Facts: Learn about the family's situation.

Gather

- Gather information about the child's/youth's situation through a Housing Questionnaire.

Analyze

- Determine whether the living arrangement of the child(ren) or youth meets the McKinney-Vento definition of homelessness.

Communicate

- Communicate when follow-ups regarding eligibility and services will occur with parent(s) / unaccompanied youth.

Seek

- Seek additional input if needed.

Role of LEAs and McKinney-Vento Liaisons



Ensure that children and youth experiencing homelessness are identified through outreach and coordination activities with other entities.



Determine eligibility by using the definition of homelessness as defined by the McKinney-Vento Homeless Assistance Act.



Assist eligible families by providing information, benefits and resources as provided by the McKinney-Vento Homeless Assistance Act, Ed Law 3209, and the Commissioner Regulation 100.2 (x).

Additional Identification Strategies

Collaborate

Collaborate with community service agencies, such as shelters, food pantries, law enforcement, legal aid, public assistance and housing agencies, mental health agencies and public health departments.

Coordinate

Coordinate with youth-serving agencies, such as drop-in centers, street outreach, child welfare, juvenile courts, teen parent programs, LGBTQ youth organizations.

Access

Access available data to inform outreach – district and regional homeless identification, poverty data, primary nighttime residence data.
